TUITION INFORMATION

Payments Session 1: Sept 4 – Oct 29 Session 2: Oct 30 - Jan 14 Session 3: Jan 15 - Mar 11 Session 4: Mar 12 to Dance Concert 2026
1 hour classes are \$160 per session, 1.25 hour classes are \$180 per session, 1.5 hour classes are \$190. There is a \$25 registration fee and a \$5 discount for each additional class per student or family member per session. Session payments must be received within 10 days after the due date to avoid a \$35 late fee. Returned check fee is \$40.00.

There are no binding contracts and you are not required to enroll in any additional sessions. Enrolled students are automatically registered into the next session. There are NO TUITION REFUNDS. Your enrollment constitutes a "Class Reservation" meaning that both classroom and teacher time are reserved. Please do not come to class feeling ill; makeup days are available. Absences must be made up during the session in which they were missed. All account balances must be paid to receive costumes and perform in the Dance Concert.

DANCE WEAR (All dancewear is available for purchase at the studio)

Hair must be secured properly. Jewelry should not be worn to class for safety reasons. Bare feet are permitted under supervised activity only.

BALLET: pink or black leotard, pink tights, pink split sole ballet shoes (Capezio Hanami canvas preferred)

TAP: black leotard, tan tights, Bloch tan taps with buckle (*Bloch taps only, please*) advanced levels ask at the front desk

JAZZ: black leotard, tan tights, caramel slip-on jazz shoes

HIP HOP: leggings, tee shirt or leotard and black suede split sole jazz sneakers.

PRESCHOOL: pink leotard, pink tights, pink ballet shoes, white **buckle** taps (*no ties*)

LYRICAL/CONTEMPORARY: black leotard, tan or pink tights, Bloch tan canvas half-soles

ACRO: tight fitting active wear, no shoes, and hair pulled up
